



- Requirements for Joining an Emory SOM Lab (see excerpt from <u>Students in SOM</u> <u>Labs/Research | Emory School of Medicine</u>)
- 7.21 Minors in Laboratories policy under revision

- Must be at least 16 years old and be hired through Emory Human Resources or Emory Temporary Services. No volunteers are permitted in SOM Labs.
- Additionally, for minors involved in any research activities (human, animal, basic science) including shadowing other research personnel in lab areas or otherwise, please reach out to the Office of Research Compliance & Regulatory Affairs (researchcompliance@emory.edu) to ensure appropriate trainings and

research safety oversight measures are in place.
