Question: An <u>Adverse Event</u> (AE) is the occurrence of an unforeseen event that negatively impacts the welfare of research animal(s), involving pain, distress, and/or death of the animal. Reporting of an AE should be done verbally or via email within 72 hours, followed by a written report within 10 business days.
